# Fisheries Management & Legislative Report

Since the Federal Government decided to arbitrarily close down the black sea bass fishery, JCAA has been very busy. We discussed this issue with Governor Corzine and DEP Commissioner Mauriello at the Governor's Surf Fishing Tournament. discussed the possibility of a lawsuit and other possible actions the Governor could take. In speaking to Deputy Commissioner Watson recently, I questioned what actions might be taken. He was waiting to see what actions would be taken by the Mid-Atlantic Council. The Mid-Atlantic Marine Fisheries Council met the week of October 12th and took no action. An attempt to bring this up for discussion was ruled out of order. I will continue contacting the Governor's Office and hope to have more information at the NJ Outdoor Alliance Rally on October 24. We received a letter from Congressmen Pallone and Adler supporting revisiting the quota and opening the fishery. We are still waiting for a letter from Senators Lautenberg and Menendez but I have been in contact with both staffs and anticipate that will happen soon.

From October 26<sup>th</sup> -29<sup>th</sup>, Sharon McKenna (JCAA Operations Manager) and I will be attending the ASA Summit in San Diego and the following week

I will be at the ASMFC Annual Meeting in Rhode Island. Dr. Jane Lubchenco, NOAA Administrator, will be at the ASA Summit and I am planning to discuss the black sea bass issue with her. I plan to bring up this issue at the ASMFC Annual Meeting. I cannot see how NMFS can justify emergency action on black sea bass when this stock is recovered, it is not overfished and overfishing is not taking place. The ASMFC Commissioners knew that their Governors could not justify this action. That was why ASMFC voted not to close this fishery. I guess I should not be surprised this action was taken by NOAA without consultation with the Mid-Atlantic Marine Fisheries Council and ASMFC. The Federal Government doesn't play by the same rules as the states. For the states to take this type of action, there would be a process including public comment. Not at the Federal level.

What should we do now? In addition to the ASMFC Meeting in November, I plan ask to revisit the quotas at the Joint Meeting of ASMFC and MAFMC in We need other states to join us in contacting their Governors, Congressional delegations and President Obama. All of us, individuals, Governors, Congressional delegations, need to express our outrage at the direction of fisheries management in general and the black sea bass specifically. I was on a conference call with ASA Saltwater Committee to discuss red snapper. During that conference call I also discussed the black sea bass issue. The JCAA release on black sea bass and the ASA Saltwater Committee on red snapper will both be discussed at the Government Affairs Committee and the ASA Summit. I have included both documents below. ASA plans to take action on both issues. JCAA will continue to issue alerts about this issue and other actions that need to be taken. Sign for alerts up at http://jcaa.org/Subscriber\_Form.asp

Black sea bass and red snapper are just the issues currently receiving attention. JCAA did not support giving the Scientific and Statistical Committee total control to set quotas. We are now seeing the damage they can do with that power. The SSC is making decisions that are much more conservative than even their data would require. These decisions are not made strictly based on models and numbers. They (SSC) also have no consideration for the history of the fisheries management of these stocks and what is actually happening in the real world. The members of the SSC are scientists who only crunch numbers. The Councils and Commissions include members who live

in the real world of fisheries management; state scientists, commercial fishermen, recreational anglers, environmentalists, state directors, legislators, and members of the interested public. When you look at the process, you realize the models are very precautionary and conservative. The information fed into the models is very precautionary and conservative. Now we have an SSC that is adding another level of conservative thinking. The National Marine Fisheries Service continues to tighten the noose around the neck of both the commercial and recreational industries. Soon there will be nothing left and they will have succeeded in killing these vital industries with no appreciable gain to the stocks of fish. In the mission statements of NMFS and ASMFC, the goal is to promote sustainable fisheries, not end fishing all together. Some of the staff at NOAA needs to read the mission statements and stop following their own agenda. Those of us who represent the recreational and commercial industries no longer feel that we are an equal part of the process. We have been made to feel like the enemy and we are facing annihilation.

As Commissioner to ASMFC, I attended four public hearings on striped bass, weakfish, shad, and black sea bass. The actions based on the hearings will be taken at the ASMFC Annual Meeting in November. I will report on that in the next newspaper. The JCAA positions on striped bass and weakfish are included below.

### JCAA position on the Draft Addendum II to Amendment 6 of the Atlantic Striped Bass Interstate Fishery Management Plan October 6, 2009

JCAA feels that the quota underage in recent years regarding the established coastal commercial quota may be indicative of some additional factors in the fishery that management has as of yet been unable to identify. Certainly the commercial fishery has demonstrated in the past that it is highly efficient. The inability to reach established quotas in many states must be regarded with some degree of caution and concern about the stock at this time.

Treatment of Unused Coastal Commercial Quota

JCAA supports:

Option 1: Status Quo.

### JCAA position on Draft Addendum IV to Amendment 4 to the Interstate Fishery Management Plan for Weakfish

October 18, 2009

JCAA regards the extremely low stock assessment of weakfish to be a very serious ongoing problem for this fishery. Unfortunately, it will require a very severe restriction on the fishery to try to evaluate more exactly the causative factors and methods needed to correct the problem.

JCAA proposes a solution similar to what was enacted for Winter Flounder. Although the decline of the weakfish stock is due to conditions other than the overfishing that was occurring with winter flounder. Overfishing of the weakfish stock does not appear to be occurring at this time and is not involved with the stock decline.

We feel that this precipitous decline in the weakfish stock anecdotally may in part be due to a displacement of the weakfish stock by the recent coincidental Croaker population explosion. Additionally, the growing inshore Spiny Dogfish stock can have a seriously adverse effect on the fall coastal migration of the 1 and 2 year old class of weakfish. The large winter bluefin tuna population off of the Carolinas probably does not help promote the size of the stock either.

There also appears to be an increasing pressure on ever decreasing population of available forage. The increase in the commercial harvest of sea herring, mackerel and squid may have upset the forage fish balance in offshore waters. Additionally, water quality problems in the bays and estuaries that potentially can affect the spawning cycle and maturation of the fry on both weakfish and forage species continue to escalate and must also be addressed.

We know that forage species are heavily affected by the industrial use of water and pollution of our rivers and estuaries. We need to address these problems and not just put all the pain on the recreational fishing industry.

We present the following realistic interim solution for your consideration:

#### Commercial Fishery:

As with the winter flounder fishery, there should be a moratorium on commercial landings with severely reduced trip limits and by-catch allotments. Any trip limit

and by-catch allotment should be so small as to prevent any possibility of a targeted by-catch fishery.

Option 2 Trip Limits

JCAA Supports: Option 2.1b (100 pounds)

Option 3 Bycatch Limits

JCAA Supports: Option 3.1b (100 pounds)

Recreational Fishery:

### JCAA supports Option 2a

The recreational sector should be allowed a 2 fish daily bag limit to act as a monitoring device for the inshore fishery. This is similar to what is the approach in the winter flounder fishery. A complete recreational moratorium will provide no beneficial effect on the stock. Seasonal closures would be contra-indicated because of the wide variation in the appearance cycles of these fish in different areas of the coast.

# JCAA Press Release: NOAA Unfairly Shuts Down Black Sea Bass October 1, 2009

NOAA announced on September 30<sup>th</sup> that they were going to close the black sea bass fishery for 180 days starting October 5th. The stated reason is that preliminary data suggests that the recreational sector will over harvest the 2009 quota. What the NOAA release failed to state is the fact that the quota in 2009 was set too low and they are allowing the same low quota to be in place for 2010. They set the original quota in 2008 believing the stock was being overfished and overfishing was taking place. They raised the recreational size limit to 12 1/2" to implement the smaller quota.

In 2008, after the new stock assessment was published and it stated that the stock was not overfished and overfishing was not occurring, NOAA did not raise the quota in response to this new information. Instead they kept an arbitrarily low quota that guaranteed overharvesting since it did not take into consideration that

the stocks were larger than they estimated. They did leave the higher  $12 \frac{1}{2}$  inch size limit in place.

This year, when it was time to set the quota for 2010, the black sea bass quota was set by the Scientific and Statistical Committee (SSC) before the Monitoring Committee of the MAMFC and ASMFC met. The SSC decided to go with status quo even though the latest approved stock assessment showed that the stocks were no longer being over fished. The Monitoring Committee met after the SSC and realized that the quota they set for 2009 was based on the condition that black sea bass was overfished and overfishing was taking place. With this Monitoring information. the Committee recommended an increase in the quota. At the joint meeting, we questioned the SSC about whether or not they had considered the same new information discussed by the Monitoring Committee when they set the quota at status quo. The response was that they had not. I made a motion asking the Monitoring Committee and SSC to hold a conference call to discuss this issue and see if there was a possibility of increasing the quota based on the available information. After a long discussion, the MAMFC voted a 10/10 tie so the motion did not move forward. The excuse given by the Council Chairman and Vice Chairman was that this would set a bad precedent. What it showed me was the callousness of these individuals relative to the needs of the recreational and commercial fishing industries? This is a new process and mistakes will be made. Until we resolve the procedural matters, there should be no problem revisiting decisions in the best interest of all concerned. For 10 council members, it wasn't important to make sure all information and recommendations were considered before final decisions were made.

After the joint meeting of the Mid-Atlantic Council and ASMFC, the ASMFC held the summer meeting in August. At this meeting we saw preliminary data that showed that the black sea bass fishery, summer flounder and scup might be exceeding their recreational targets. It was decided by ASMFC Policy Board to ask the Summer Flounder, Scup and Sea Bass Board to meet via conference call to discuss this issue. There was a conference call on sea bass, summer flounder and scup. The controversy was regarding the Marine Recreational Statistical Survey and how accurately it reflects what is actually happening. Again, this data was preliminary and had not been subject to the in house peer review. The states voted not to shut down the black sea bass fishery based on preliminary and unreviewed MRSS data. We also realized that it would be difficult too for the states to shut down through emergency action since this overage would not hurt the stocks. We realized that in December we would have to review all the data and take actions on the 2010 fishery to guarantee we stayed within quota. What NOAA did through its arrogance is put through an emergency action using preliminary without consulting

the public. As the Governor's Appointee to ASMFC, I was not notified prior to the release. The NJ Division of Fish and Wildlife were also not consulted or notified in A release from the Mid-Atlantic Council suggests they were not consulted or notified either. This would not have happened during President Bush's administration. Bill Holgarth would have consulted with at least the state directors and council members before implementing an action like this. It seems the new director of NOAA has decided to take unilateral action. This is not how a partnership works to manage fisheries. The JCAA is calling on the recreational community to notify President Obama and our members of Congress that this is unacceptable. We can't have Dr. Jane Lubchenco, NOAA Administrator, taking arbitrary action with no regard for or understanding of recreational fishing and the industry that it supports. This just reinforces our concerns when she replaced the recreational representatives on the Mid-Atlantic Marine Fisheries Council. We also need for each of you to contact your Governors and Legislators, asking them to take whatever action they can. We need for NOAA to rescind this closure immediately. We need NOAA to get the Monitoring Committee and Science and Statistical Committee to establish realistic quotas.

We have all seen the stimulus packages to bail out banks and the auto industry. We have all seen the stimulus packages that are designed to create jobs in both the public and private sectors. These actions by NOAA on black sea bass and red snapper in the Gulf are doing exactly the opposite. If this continues NOAA will have created another economic crisis and increased the unemployment roles. This time we need to avoid the problem and find a common sense solution before we need another bailout. JCAA will keep you posted on our upcoming action on this issue.

### Feds to 60 Million American Anglers: We don't need you SHIMANO AMERICAN CORPORATION

A recently published administration document outlines a structure that could result in closures of sport fishing in salt and freshwater areas across America. The White House created an Interagency Oceans Policy Task Force in June and gave them only 90 days to develop a comprehensive federal policy for all U.S. coastal, ocean and Great Lakes waters. Under the guise of 'protecting' these areas, the current second phase of the Task Force direction is to develop zoning which may permanently close vast areas of fishing waters nationwide. This is to be completed by December 9, 2009.

Dave Pfeiffer, President of Shimano American Corporation explained, "In spite of extensive submissions from the recreational fishing community to the Task Force in person and in writing, they failed to include any mention of the over one million jobs or the 60 million anglers which may be affected by the new policies coast to coast. Input from the environmental groups who want to put us off the water was adopted into the report verbatim – the key points we submitted as an industry were ignored.

"Recreational fishing generates a \$125 billion annual economy in the United States and supports jobs in every state according to government figures. Through the Sport Fish Restoration program, anglers have provided more than \$5 billion through excise taxes on fishing tackle to fishery conservation and education for decades.

In addition to the economic aspects, anglers lead the nation in volunteer conservation efforts on

behalf of improving fish habitat, water quality and related environmental areas. "There was no mention of the fishery conservation efforts which anglers have led for over 50 years in every state —an environmental success story that has no equal in the world", said Phil Morlock, Director, Environmental Affairs for Shimano. "The Task Force did not make any distinction between the dramatic differences between harmful commercial fishing harvest methods and recreational fishing, even though we spelled it out for them in detail," added Morlock.

Claiming to be the result of a public consultation process the report states, "Having considered a broad range of public comments, this report reflects the requests and concerns of all interested parties."

The original White House memo and not surprisingly the Task Force report contains multiple references to developing a national policy where Great Lakes and coastal regions are managed, "consistent with international law, including customary international law as reflected in the 1982 United Nations Convention on the Law of the Sea" - a 300 page treaty the U.S. has never ratified.

"We question what implications there will be for state authority and jurisdiction in the Great Lakes and coastal regions if the U.S. adopts the U.N. Treaty," said Pfeiffer.

The report makes it clear that future authority for implementing the policy for coastal and inland waters will fall under White House jurisdiction with a new National Ocean Council comprised of over 20 federal agencies at Cabinet Secretary or Deputy Secretary level. No reference to Congressional jurisdiction is indicated.

"This significant change in U.S. policy direction is the result of a 90 day fire drill process as ordered by the President that, not surprisingly, lacks balance, clarity and quality in the end product," said Morlock. "People who simply want to take their kids fishing on public waters deserve better from their government," he added.

Shimano is joining with other members of the recreational fishing industry to urge anglers to contact their members of Congress and the administration to request this process be required to adopt the economic, conservation and social contributions of recreational fishing as key elements of the policy. It is critical that we ensure Congressional oversight and state jurisdiction and management continues.

## Political Hurricane By John Koegler

The Interim Report of the White House Interagency Oceans Policy Task Force was released on September 10. This task force was created by President Obama on June 12, 2009 and was given only 90 days to draft and submit this Interim Report.

The president's expressed goal: "To succeed in protecting the oceans, coasts and Great Lakes, the United States needs to act within a unifying framework under a clear national policy, including a comprehensive, ecosystem-based framework for the long-term conservation and use of our resources." He appointed Nancy Sutley of the White House Council of Environmental Quality as Chairwoman.

This report makes it clear that future authority for implementing policy for coastal and inland waters will be totally under the White House jurisdiction. The new National Ocean Council will be comprised of over 20 current federal agencies at the Cabinet Secretary or Deputy Secretary level.

This is a total change in management of our ocean and inland water resources. This new Ocean Council eliminates all congressional oversight and authority. It places all authority for ocean and inland water management under White House (Presidential) control!

A new White House controlled Ocean Policy Task Force has terrible future implications for recreational fishing access to both fresh and saltwater areas.

The Interim report refers to developing our national policy so that the Great Lakes and coastal regions are managed "consistent with International law as reflected in the 1982 United Nations Convention on the Law of the Seas." The US has never ratified the "UN Law of the Seas" so the White House is side-stepping the Congress to make this sweeping policy change.

The single most obvious omission in the report is there is no reference to recreational fishing as a key activity for either the oceans or the Great Lakes. There are many submissions by recreational groups. The Shimano letter was only written after all their attempts to amend the interim report failed. Clearly, the proposed future water uses will be preservationist oriented. The preservation members of the council propose to lock up all public waters instead of promoting sustainable uses such as recreational fishing. All of the items covered by the Shimano letter are a major threat to your continued fishing in the United States.

You need to act immediately or lose your right to fish. Remember, this is only an Interim Report, but it does

show the current direction and emphasis of the Obama Administration. It is up to us to ensure our voices are heard and that the final report includes recreational fishing as a key activity in our oceans and the Great Lakes.

### Swordfish Catches

Despite the huge amount of work at NMFS the commercial swordfish landings remain close to 2008 landings with a landings increase of just 239,000 pounds DW. A major push was supported by the commercial fishermen and lobbyist to scrap the current fishing limits and rules. They demanded uncontrolled sword fishing so the US does not lose any of their quotas at the next ICCAT meeting in November, all of which is nonsense.

As noted previously, the big problem is not catching swordfish but selling fresh swordfish at a price high enough so they make a profit. Massive frozen imports from the Indian Ocean have sharply depressed swordfish prices at the wholesale level. This has resulted in fishermen only making trips at a time when good catches were sure to be made. The result is fewer trips and fewer fresh swordfish from the US fishermen.

Where is the reason to remove all the landing limits for commercial fishermen? This is typical commercial baloney.

#### **Commercial Bluefin**

The August 31 report on US landings of Bluefin tuna reports shocking long line increases. One of the huge problems is the continued increase in Bluefin landings from the Gulf of Mexico spawning area. NMFS permits continued long lining in the Gulf during spawning time so they are not shut down in the landings of other tuna. But over the last several years the number of Giants landed and sold has continued to increase.

The number of giants landed in 2007 by long line fishermen was 247 fish. The number in 2008 was 266 and the number in 2009 was 346. This is an increase of 99 spawning size giants and would clearly affect the future spawning success of the giant Bluefin tuna.

The solution is easy, end bluefin tuna fishing in the Gulf during their spawning time. NMFS either desires to save the bluefin tuna or they do not. Keeping the Gulf long line fishery open during giant spawning time is criminal and must be stopped.

#### **Spiny Dogfish**

The spiny dogfish "Plague of Locusts" has become so acute that New England fishermen are having trouble catching anything else that is not so damaged by the dogfish it cannot be sold. As usual, NMFS says, "We're not seeing the whole picture," this despite a huge increase in reported spawning age females from a low of less than 50,000 MT in 2001 to a huge unexplained female population explosion to over 198,000 MT. in 2008. Add the male population estimate of 400,000 MT and NMFS population estimate is 598,000 MT. Other scientist estimates are over 2,000,000 MT. That is a difference of more than 300%, which is clearly impossible. Somebody's estimates are way wrong.

New England commercial fishermen are now labeling spiny dogfish "Vermin of the Ocean." NMFS low dogfish population estimates are horribly wrong. Locally many fisheries are closed down because if anglers drift off wrecks between November 1 and May 1, they are covered up by dogfish. This is 7 months of the year that New Jersey anglers cannot bottom fish because of the excessive dogfish numbers. Anglers cannot just complain but make your concerns known to your ASMFC commissioners and MAFMC members. Demand that they increase the current spiny dogfish commercial quota by 300% or more immediately!
