Participants expressly and unconditionally agree as a condition to the acceptance of their application that JCAA and its administrators, agents, officers, directors, committee members and tournament sponsors are not liable for any claims, suits or obligations arising out of or resulting from participation in this event as a result of negligent or intentional conduct by JCAA and its administrators, agents, officers, directors, committee members and tournament sponsors. Participant agrees to indemnify and hold JCAA and its administrators, agents, officers, directors, committee members and tournament sponsors harmless for any and all claims and costs, including attorney fees, arising out of his or her conduct resulting from participation in the tournament.

I understand that in conjunction with engaging in the JCAA Tournament, I could experience certain hazards and become involved in certain risks. I further recognize that it would be impractical as well as unfair for the JCAA and its administrators, agents, officers, directors, committee members and tournament sponsors and/or any and all other persons or boat owners and their crew directly or indirectly involved in or connected with the Tournament to be liable or responsible in any way for my safety.
